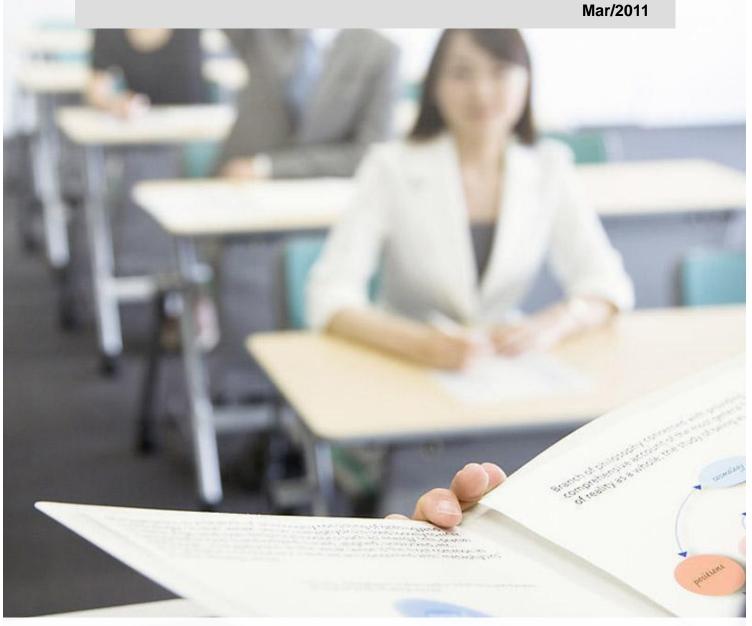

5.1.1 Market

China education and training market kept a high growth rate in 2009. The total market value of China education and training market was about RMB** billion in 2009, and will increase to RMB** billion at a CAGR at **% in 2012. Specifically, the CAGR of non-government funded education will reach 16%, much higher than that of state-run education at 9%.

Market Scale and Growth of National Education & Training Industry, 2009-2012E

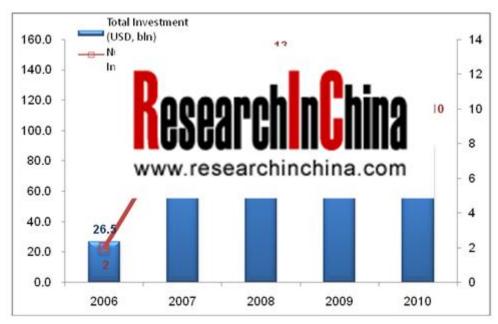

In 2010, the total investment of China education and training market showed a slightly decline YoY, while the total private equity investment represented an obvious rise YoY. 8 investment cases of this industry were revealed in 2010, which accumulated USD **million totally and USD 3.43 million on average single investment. Meanwhile, there were 2 private equity investment cases with a total value of USD 62.74 million and USD 31.37 million on average single investment.

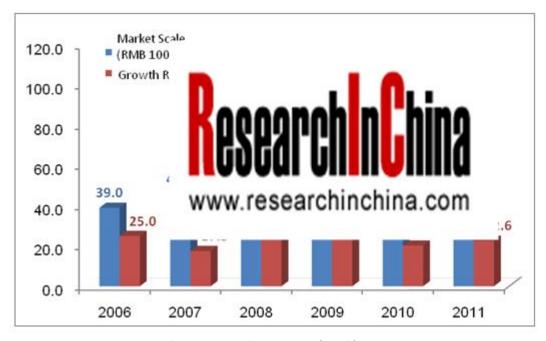

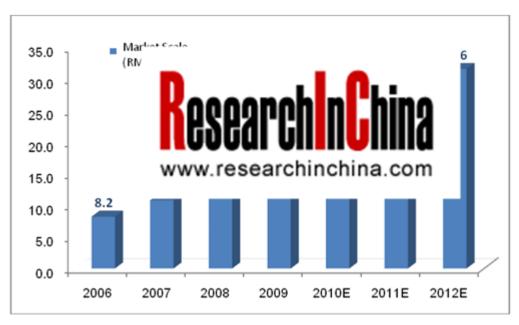
The market size of IT training in China was estimated to reach RMB ** billion in 2010, up 20.2% YoY. It is expected to hit RMB ** billion in 2011 with a YoY growth rate of nearly 23%. Furthermore, it is predicted that the growth rate of China IT training market size will keep at 20%-25% in the next three years.

5.3.1 Status Quo

Influenced by the financial crisis of 2009, more and more people spent more time on pursuing advanced studies, which lead to the increased market of vocational training, especially English training. On one hand, the economic downturn has stimulated people's eager of self-improvement. On the other hand, the fever of study abroad caused by strong RMB exchange rate and lowered oversea study expenses also accelerated the development of English training market.

Comparison among New Oriental, Global Education & Technology, TAL Education Group and Xueda Education Group by Outlet Quantity, 2008-2009

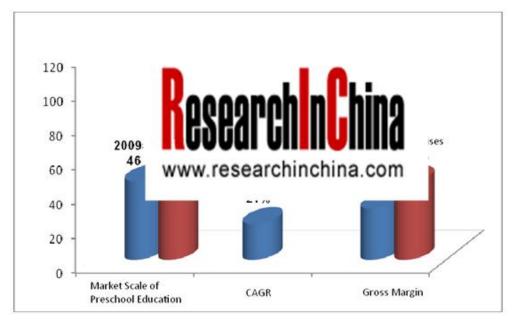

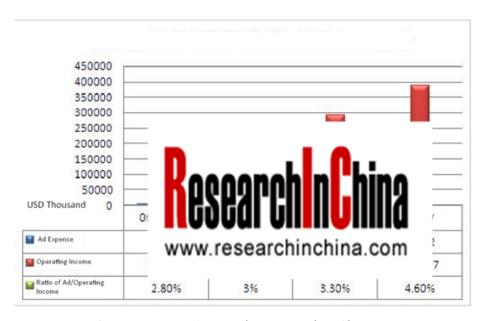
Market Scale and Growth of Preschool Education, 2009-2013 (bn)

Advertisement Expense of New Oriental, FY2006-FY2010



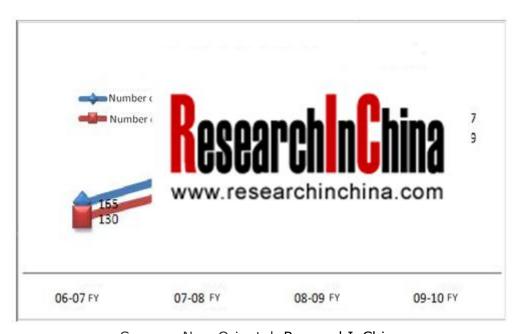

6.1.3 Network Expansion and Enrollment Development

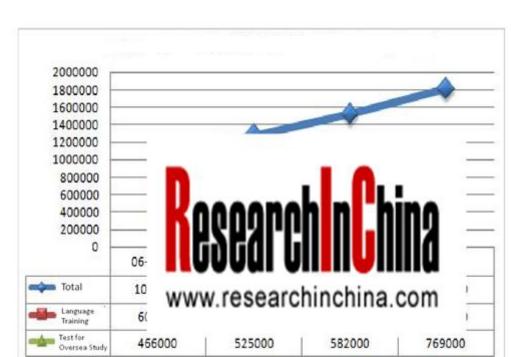
According to the fiscal year statistics of network expansion in 2006-2010, the total network of New Oriental increased 202 after its listing, up 122%.

Enrollment of New Oriental, FY2006-FY2010

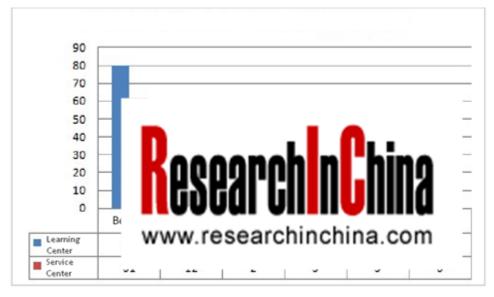

6.2.3 Network Expansion and Faculty & Enrollment Development

Currently, TAL Education Group owns 109 learning centers and 87 service centers in Beijing, Shanghai, Shenzhen, Guangzhou, Tianjin, and Wuhan. Learning center is responsible for management of teaching facilities, while service center provides services including course consultation, course selection, student registration and other services. There are 80 learning centers in Beijing, which is the largest amount of learning centers of TAL Education Group, followed by Shanghai with 14 learning centers.



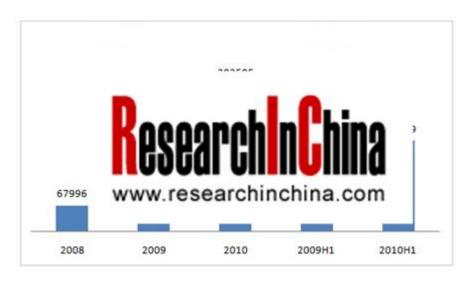
National Distribution of TAL Education Group's Learning and Service Centers, 2010
